## Important Information About this Agreement and the Law

- 1. If the tenant wants to cancel this agreement, the tenant can do so by giving written notice to the landlord within five calendar days after the agreement is signed. The agreement cannot come into effect until at least six calendar days after it is signed.
- 2. A landlord can only agree to increase the rent if at least 12 months have passed since the last rent increase or since a new tenant moved into the unit.
- 3. If the landlord and tenant sign this form, it takes the place of a Notice of Rent Increase. Therefore, the landlord does not have to give a notice to increase the rent.
- 4. If the landlord does not do the work or provide the service that has been agreed to, the tenant may apply to the Ontario Rental Housing Tribunal and ask that all or part of the rent increase above the rent control guideline be considered invalid. The tenant must apply no later than two years after the date the rent was increased pursuant to the agreement.
